## Emergency Medical Technology Criminal Background Check

### **EMT Student:**

Students planning to take the EMT104 or EMT272 courses must provide a criminal background check or dept. approved substitute documentation in order to attend clinicals during EMT104 and EMT272 courses.

### **What is Required:**

Participating clinical hospitals will have the final say in which students are allowed to attend their facility as clinical students. Offenses that participating hospitals have declined to accept include, but are not limited to:

- Drug convictions
- Sexually based offenses
- Violent crimes
- Any other conviction at the discretion of the participating clinical sites.

A copy must be provided to your instructor prior to the clinical portion of class. Due to varying turn around times, students are not required to provide the background check in order to register. **Important:** students with a criminal history including any of the above are subject to removal from the EMT104 and EMT272 courses.

### **What Will Be Accepted?**

Any of the following can be used to satisfy the criminal background check requirement:

- Military or employer criminal background checks within the last 12 months will be accepted.
- Current AZ concealed weapon carry permit.
- Online criminal background check from any agency on the Internet within the last 12 months.
- A signed letter from your employer verifying that they have a current criminal background on file clear of the above offenses. Letter must provide contact information for verification.

### **What Will NOT Be Accepted?**

The following will not satisfy the criminal history requirement:

- Background check over 12 months old.
- An online search for wants and warrants only
