**ELIGIBILITY REQUIREMENTS:**

Applicants, not attending high school, must demonstrate financial need through their federal need analysis results, FAFSA, for the current award year.

- Applicant must have an official EFC on their federal need analysis no greater than 5250.
- Applicant must be enrolled in 6 or more credits.
- Applicant may not be awarded Federal Financial Aid (Title IV).
- Applicant must meet the Maricopa Community Colleges Standards of Satisfactory Academic Progress for Financial Aid Eligibility.
- Applicant may not have achieved Bachelor's status.
- Students classified as out of state for residency purposes, except refugees classified as non-resident, are not eligible for this program.
- Applicant may not be in default on a student loan or have a student owed repayment for federal grants.
- Applicant must complete, with passing grades of D or better, at least half-time enrollment with at least a C (2.0) term average to be eligible for the next term award.
- Awards will be in the amount of \$500 fall and \$500 spring, not to exceed the MCCCCD total cost of education.

**GENERAL INFORMATION:**

Funds will be awarded based on FAFSA completed date and availability of funds.

If awarded federal financial aid after receipt of this grant, the grant will be cancelled, possibly creating a debt for the student.
